POSITION SUMMARY

The Assisted Living Coordinator will be directly interacting with Taku River Tlingit Citizens, on a daily basis, providing care and programming directly with increasing the awareness and promoting a healthy living lifestyle. Supporting and supervising the home support workers team and co-ordinating with the Community Health Rep, reporting directly to the Health & Wellness Manager. A knowledge of services in the community and neighbouring communities is a must to utilize all resources available to ensure the safety and health of all community members. This position requires some travel between Atlin, 5 Mile and occasionally Whitehorse. The primary work location will be at 5 Mile, Tutan Hit Building. This candidate will display a commitment and compassion for clients and must adhere to confidentiality.

DUTIES AND RESPONSIBILITIES

- Develop and maintain healthy relationships with all community members. Understanding their needs for a healthy lifestyle and assisting them where possible to develop such.
- Assess clients needs as to needing extra support in home care and to which level that is needed. Aligning clients with programs specific to their needs/interests.
- Oversee weekly client support list from the weekly schedule the home support workers provide the week prior, for the following day/week as to client care.
- Supervise over home support workers to ensure all documentation is recorded in full and on time at every
 visit to each client. If no care is provided to a client on a scheduled day a report must be written as to
 why. (Substance abuse, refusal, not home etc.)
- Complete a weekly review of client care records and look for increased or decreased services or discrepancies. Maintaining up to date records for each client. Debrief weekly with CHR.
- Reporting concerns for team or clients to Community Health Representative.
- Ensuring Food Bank clients/documents and program are maintained and organized as to scheduling of delivery and organization of hamper pick up. Ensuring client data is up to date and relevant.
- Assist the home support workers in the weekly meal plan for Elder Meal assistance 3x per week keeping in mind any client dietary restrictions.
- Provide a bi-weekly list to CHR for cleaning supplies, groceries, incontinence supplies and dietary supplements as needed.
- Report and review with CHR weekly to discuss ongoing community care needs, programming maintenance and opportunities.
- Able to acquire Food safe and First Aid training within first 3 months of employment.
- Work with CHR to implement healthy and consistent programming into the community.
- Plan, coordinate and deliver consistent community gathering programming with CHR.
- Always demonstrate and maintain a positive and healthy image within the community.
- Strive to be improving existing services and programming and adapt as needed.
- Sufficient with computer knowledge in Word/Excel/Email/Typing and reporting storage.

- Attend Health and Wellness department staff meetings when required and provide progress updates and concerns to team members.
